Notice is hereby given that **Voltalia UK Ltd**, ("the Company") with company registration number **07489990**, having its registered office at **The Wheelhouse**, **Bond's Mill Estate**, **Stonehouse**, **Gloucestershire**, **England**, **GL10 3RF** has applied to the Scottish Ministers for consent under section 36 of the Electricity Act 1989 to construct and operate a **ground mounted solar photovoltaic (PV) development**, **Battery Energy Storage System (BESS)**, **associated infrastructure**, **access**, **and landscaping** at **Bowshiel Farm** (Central Grid Reference **78702 67899**). The installed capacity of the proposed Solar PV generating station would be up to approximately **165 MW**, and the **BESS would have an installed capacity of up to approximately <b>80 MW**. The proposed development is subject to Environmental Impact Assessment (EIA) and an EIA Report has been produced.

The Company has also requested a direction under section 57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.
